Our Commitment

Our Privacy Policy was developed as an extension of our commitment to interact and provide our fans with the highest level of integrity. The Policy is designed to assist you in making informed decisions when using our Site. This statement will be continuously assessed against new technologies, business practices and our customers' needs.

What Information Do We Collect?

When you visit jeffgarlin.com, you may choose, at your own discretion, to sign up for the newsletter. This information is collected on an individual basis.

1. Personal Information You Choose to Provide

Email Information

In addition, if you choose to correspond further with us through email, we may retain the content of your email messages together with your email address and our responses. We provide the same protection for these electronic communications that we employ in the maintenance of this website.

2. Web Site Use Information

How Do We Use the Information That You Provide to Us?

We strictly use your information for the distribution of the jeffgarlin.com Newsletter. Membership list for our newsletter, including name, zip code, and email addresses (when accessible) will be made available to the webmaster and the Artist upon request, and no others. Occasionally, we may also use the information we collect to notify you about important changes to the site. As a customer, you will be given the opportunity to unsubscribe from these email communications at any time if desired.

Sharing Information with Affiliates

We do not do this at present and will not share personally identifiable information with outside companies.

Sharing Information with Strategic Partners

We may enter into strategic alliances or partnerships with third parties who may be given access to information including name, and email. In connection with strategic marketing alliance or partnerships, we will retain all ownership rights to the information. We currently do not participate in these alliances.

Notice of New Services and Changes

Occasionally, we may also use the information we collect to notify you about important changes to our Site, such as new information or the addition of features we think you will find valuable. As our client, you will be given the opportunity to notify us of your desire not to receive these offers by following instruction contained in the email to opt out if desired.

How Do We Protect Your Information?

We only collect email addresses to send fans/subscribers the Newsletter. We are not collecting information for internet commerce or the sale of merchandise. We utilize encryption/security software to safeguard all information, nonetheless.

Expectations. Our values, ethical standards, policies and practices are committed to the protection of customer information. We are not collecting confidential information, though we shall limit the use and disclosure of any information to only authorized personnel.

Do We Disclose Information to Outside Parties? No. We may provide aggregate information about our web site traffic patterns and related web site information to a trusted affiliate, but this information will not include personally identifying data, which we do not collect at this time, except as otherwise provided in this Privacy Policy.

What About Legally Compelled Disclosure of Information? We may disclose information when we, in good faith, believe that the law requires it or for the protection of our legal rights.

What About Other Web Sites Linked to Our Web Site?

We are not responsible for the practices employed by web sites linked to or from our site nor the information or content contained therein. Often links to other web sites are provided solely as pointers to information on topics that may be useful to the user.
